ABSTRACT

Andriani Endah Nilamsari. C1305504. 2009. *Request Expressions in the movie entitled 10 Things I Hate About You*. Thesis: English Department, Faculty of Letters and Fine Arts, Sebelas Maret University.

This research is based on Socio-Pragmatics approach. The aims of the study are (1) to describe the types of request expressions employed in the film entitled *10 THINGS I HATE ABOUT YOU*. (2) to describe how each type of request expression is applied in the film. (3) to describe the factors that influence the use of each type of request expressions in the film.

This research is a descriptive study. The data are all utterances of request expressions in the film *10 THINGS I HATE ABOUT YOU*. They are classified by using Tsui's classification of request. Then, each type of request expression that applied in the film is analyzed by using Ethnography of Communication with SPEAKING formula and Politeness Theory as the guiding theory. Furthermore, Holmes Social Dimension of Communication is used to reveal the factors that influence the choice of request expressions in the conversations.

The result of this research shows that there are three types of request expressions in the film namely offer, request for action and proposal.

It is also found in some data that direct request expression or less polite request expression and polite request expression are commonly found in informal situation between intimate participants.

Some factors influence the use of request expressions are the situation and status. Situation here means that the conversation takes place in informal and formal situation. The participants will state his or her request angrily and in a high tone if there are frictions between the participants. If the participants deliver his or her request happily and state the request in a low tone, they are involved in a good atmosphere. Most of the participants in the data have the same position. It means that the relationship between the participants is equal. Social status scale between superior and subordinate also happen. The situation also influences the relationship between the participants. It means that the conversation occurs in a good atmosphere and the relationship between the participants is close.
