





ABSTRACT

This thesis aims to (1) explore the impact of video dubbing in improving students' speaking pronunciation; (2) find out the difficulties in applying video dubbing to improve students' speaking pronunciation. This research was carried out at the English Club students of SMK Gula Rajawali Madiun in the academic year of 2017/2018.

The subject of the research consisted of 20 students, 14 female students and 6 male students. The research applied classroom action research in two cycles. There were four meetings in each cycle which consisted of four steps: planning, implementing, observing, and reflecting. In collecting the data, researcher used observation, interview, video and audio recording to observe the implementation of video dubbing during teaching learning process and test to find the improvement of students' pronunciation during the implementation of video dubbing.

The research findings showed that (1) the implementation of video dubbing could improve students' pronunciation. The mean score in pre test improved from 57 into 63 in test of cycle 1, and 75 in test of cycle 2. The improvement contains all aspects of pronunciation which are vowels, diphthongs, and consonants. In addition, the improvement of all aspects of pronunciation reached the criterion of success, which were more than 70 in average. However, there were some difficulties in applying video dubbing to improve students' pronunciation, as follow: (1) students got nervous in recording session of video dubbing; (2) students were noisy in doing practice of adjusting voice and video (3) students needed repetition in recording session of video dubbing. It can be concluded that the implementation of video dubbing in learning process has beneficial effect on students' speaking skill, especially in pronunciation.

ABSTRAK

Penelitian ini bertujuan untuk (1) menjelaskan sejauh mana video dubbing bisa meningkatkan kemampuan siswa dalam melafalkan bahasa Inggris; (2) mengetahui kesulitan-kesulitan yang dialami dalam mengaplikasikan video dubbing untuk meningkatkan kemampuan siswa dalam melafalkan bahasa Inggris. Penelitian ini dilakukan oleh siswa klub bahasa Inggris SMK Gula Rajawali Madiun tahun pelajaran 2017/2018.

Subjek penelitian ini terdiri dari 20 siswa, dimana terdapat 14 siswa perempuan dan 6 siswa laki-laki. Penelitian ini dilakukan dalam 2 siklus dan terdapat empat pertemuan tiap siklusnya dimana terdiri dari 4 langkah, antara lain: perencanaan, tindakan, observasi dan refleksi. Dalam memperoleh data, peneliti menggunakan teknik wawancara, observasi, rekaman video, dan foto untuk menganalisis penerapan video dubbing dalam proses pembelajaran dan tes untuk mengetahui peningkatan kemampuan siswa dalam pelafalan bahasa Inggris ketika menggunakan video dubbing.

Hasil temuan penelitian menunjukkan bahwa (1) penerapan video dubbing mampu meningkatkan kemampuan siswa dalam melafalkan bahasa Inggris. Rata-rata nilai dalam pre tes meningkat dari yang sebelumnya 57 menjadi 63 di tes siklus 1 dan 75 di tes siklus 2. Peningkatan tersebut terdiri dari semua aspek pelafalan, yakni huruf fokal, diftong, dan konsonan. Selain itu, peningkatan semua aspek pelafalan mencapai standar ketentuan minimal yakni rata-rata diatas 70. Namun, ada beberapa kesulitan yang dialami dalam menerapkan video dubbing untuk meningkatkan kemampuan siswa dalam melafalkan bahasa Inggris, antara lain: (1) siswa gugup saat sesi perekaman dalam video dubbing; (2) siswa gaduh saat latihan menyamakan tempo suara dengan video untuk latihan (3) siswa membutuhkan pengulangan saat sesi rekaman dalam video dubbing. Sehingga dapat disimpulkan bahwa penerapan video dubbing dalam proses pembelajaran mempunyai dampak positif terhadap kemampuan berbicara siswa terutama dalam hal pelafalan bahasa Inggris.
